9. Development report - update / Entwicklungsbericht

Roger Willen reported about the development program:

"Since the World Championship with its great media presence I have received requests from various countries. The difficulty is always to qualify these requests.

Two Application Forms have arrived in the last weeks. This concerns Bahamas and Macedonia. I am still waiting for further information from both candidates.

From the following countries we have inquiries which I consider to be serious: Portugal, Romania, Uganda

In Portugal a first training with Cartsten Stenmanns from MTV Oldendorf took place 2 weeks ago.

Further requests that need to be checked more closely are: Ghana, Haiti, Mexico.

I would like to mention the contact to AICS - Associazione Italiana Cultura Sport (Italian Association for Culture and Sport).

This organization has the mission to promote sport in Italy.

I am in the process of setting up a "Train the Trainer" programme with those responsible, who were also in Winterthur.

## Reduction of the Membership fee

As part of the IFA Development Program, the annual membership fee is reduced by €100 each for three concrete annual development goals.

Initial discussions have taken place in Winterthur. The following nations were interested: Australia, Belgium, Denmark, India and the Netherlands.

Belgium is the only nation to have submitted a detailed program with 3 concrete goals for next year.

In the next few days we will send a reminder that the 2020 development goals must be submitted by 30 November."
